New Beach Access	Meegan Tony	<p>Tony went through the options that were presented at the community consultation meeting back in September 2021, highlighting the pro's and con's to the group.</p> <p>Outcome:</p> <p>Bangalee Beach Access Reference Group agreed to (2) two options for consideration and redesigning:</p> <p>Option 1: Utilise existing road where possible, construct new access and use existing beach access ramp at resort <u>(Preferred Option- dependant on Iwasaki)</u></p> <ul style="list-style-type: none"> • Make this flexible to change the location of the beach access ramp in between the resort ramp and Bangalee community <p>Option 2: Upgrade and redirect traffic along Byfield Road and create new access to beach at Corio Bay</p> <p>Option 3: Create beach access through the National Park from Byfield Road. 13km of track for new option and would be an environmental benefit to Department of Parks and Wildlife. This would remove any options impacting Iwasaki future development.</p>
